



Privacy Policy (Jan2016)

Your privacy is important to IConduct.

We have created this Privacy Statement as we are committed to protecting your privacy and the confidentiality of your personal information.

This privacy statement describes IConductCloud web site, our data integration platform and related services (the “Service(s)”) privacy practices and the options you have for the way your personal and/or organizational information is collected, used, and disclosed.

The information we collect is only used to communicate with our users and is never shared with other organizations for commercial purposes.

IConduct may have limited relationships with third parties to assist us in servicing you. These service providers are contractually required to maintain the confidentiality of the information IConduct provides.

The Information We Collect:

We ask for certain information like your name, email address, time zone and account credentials to use IConduct. We use this information to run IConduct and other operations like logging and analytics. For your convenience, we use cookies so you don't have to log in every time you visit our website.

Data Security

To prevent unauthorized access, maintain data accuracy, and ensure the correct use of information, we have put in place appropriate physical, electronic, and managerial procedures to safeguard and secure your information.

Third-Party Service Integration

Our Service allows you to integrate and use data from various third-party services (“Third-Party Services”). To use these capabilities, you may need to authenticate, register for or log into the Third-Party Services through the Service. E-Mail

We use return email addresses to answer the email we receive or as means of update in regard for services activity. Such addresses are not used for any other purpose and are not shared with outside parties.

We will provide you with the ability to opt-in and opt-out of receiving communications from IConduct.

Legal Disclosures

IConduct reserves the right to analyze personal information on an individual basis to address problems with the Web site and to disclose personal information as required by regulation or court order.
